# The NAVRA Annual Florida Rescue Challenge 2022 – Miami-Dade

## Registration Form

Before you go ahead and register, please make sure that your team has been selected by your organization representative to participate at **The NAVRA Annual Florida Rescue Challenge 2022 – Miami-Dade**.

Completion of this registration form indicates your acceptance of the following terms and conditions:

- The last day for receipt of the completed registration forms, documents and payment is **OCTOBER 28<sup>th</sup>, 2022**
- If you are entering the Vehicle Extrication Challenge, Rapid Intervention Team Challenge or the ALS-Medical Challenge, you will need to pay entry fees for each challenge.
- The entry fees per team are (including entry to selected challenge/s):
  - **Vehicle Extrication Challenge: \$500**
  - **Advance Life Support Medical Challenge: \$300**
  - **Rapid Intervention Team Challenge: \$300**
- **The NAVRA Annual Florida Rescue Challenge 2022 – Miami-Dade** will be limited to a maximum of 24 Teams each for the Vehicle Rescue Challenge and the Rapid Intervention Crew Challenge. The ALS-Medical Challenge will allow a maximum of 25 Teams.
- **NOTE: All Teams and/or Team members in the Extrication Challenge must be registered members of NAVRA.**
- All transport arrangements are the responsibility of individuals and team organizations.
- Note that teams will be responsible for their own food and beverages during each day's activities for the duration of the Challenges. There will be a number of food concessions around the venue throughout the event providing a variety of local and international food.
