## Registration Form

Before you register, please make sure that your team has been selected by your organization's representative to participate in **NAVRA's National Rescue Challenge 2024**.

Completion of this registration form indicates your acceptance of the following terms and conditions:

- The last day for receipt of the completed registration forms, documents and payment is **May 17th, 2024**
- If you are entering the Vehicle Extrication Challenge or the ALS Medical Challenge you will need to pay entry fees for the Challenge.
- The entry fees per team are (including entry to selected Challenge/s):
  - **Vehicle Extrication Challenge: \$1500:00**
- **NAVRA's National Rescue Challenge 2024** will be limited to a maximum of 20 Teams for the Vehicle Extrication Challenge.
- **NOTE: All Teams and/or Team members in the Extrication Challenge must be registered members of NAVRA.**
- All transport arrangements are the responsibility of individuals and team organizations.
- Note that teams will be responsible for their own food and beverages during each day's activities for the duration of the Challenge. There will be a number of food concessions around the venue throughout the event providing a variety of local and international food.
